### THE EXHIBITOR UNDERSTANDS AND AGREES TO THE FOLLOWING:

1. Management, its agents, officers, or employees shall not be liable for property damage or personal injury to Exhibitor, its agents or employees, which may occur. Exhibitor waives any claim against Management and assumes all liability for loss or damage to Exhibitor's property entrusted to the premises. Exhibitor shall hold Management harmless and shall indemnify Management against all liability or expenses arising out of any claim of injury or damage to any person or property, together with all costs in connection with the defenses thereto, including attorney's fees.
2. SET-UP: Set-up of booths must be completed at show's opening and must remain set-up and open for business until show closing. Booths and aisles must be kept clear for safe access throughout show hours. Tables must be covered with approved flame retardant cloth.
3. Management reserves the right to demand removal by Exhibitor of any items which may not be in keeping with the show's image. NO REPRODUCTIONS WILL BE PERMITTED.
4. Management reserves the right to make rules and regulations it deems proper and necessary, whether it be written or oral, and Exhibitor agrees and accepts such rules and regulations and interpretation thereof as is set forth by Management.
5. All municipal, state and federal requirements in connection with sales must be fulfilled.
6. This contract cannot be assigned without proper written consent of Management.
7. No booths may be shared without proper written consent of Management.
8. If any cause whatsoever makes it impossible to have the show, this agreement shall be terminated and Management shall not be liable for any resulting damage or claim.
9. Notification must be made in writing 30 days prior to show for cancellation of booth space or Management shall have the right to retain booth rent.
